**RESOLUTION OF THE PLUM BOROUGH MUNICIPAL
AUTHORITY AMENDING RESOLUTION NO. 2017-04
CONCERNING CLOSED CIRCUIT TELEVISION (CCTV)
SANITARY SEWER LATERAL INSPECTIONS PERFORMED
BY THE PLUM BOROUGH MUNICIPAL AUTHORITY.**

WHEREAS, the Plum Borough Municipal Authority is responsible for maintenance and operation of public sewer facilities and systems located in Plum Borough and surrounding areas; and

WHEREAS, the Plum Borough Municipal Authority has implemented by resolution a fee for inspections upon the sale or refinancing of property of private house laterals; and

WHEREAS, the Plum Borough Municipal Authority is desirous of expanding and clarifying when inspections shall be required.

NOW, THEREFORE, BE IT RESOLVED this 26 day of Apr 2018:

SECTION I: An inspection fee for closed circuit television (CCTV) shall be charged by Plum Borough Municipal Authority for inspections upon the conveyance, transfer, gift, devise, sale, or upon reasonable suspicion infiltration and inflow is entering a private house lateral which has its terminus in the Plum Borough Municipal Authority public sewer system. This fee shall become effective upon the passage of this Resolution. Said fee charged shall be \$300.00 per residence.

SECTION II: If it is determined after reasonable suspicion that infiltration and inflow is entering the private house lateral, the property owner shall be given sixty (60) days written notice to correct said infiltration and

inflow. In the event the property owner fails to correct the infiltration and inflow, a surcharge/penalty will be assessed against the property owner until the infiltration and inflow is removed to the Authority's satisfaction. Said surcharge/penalty shall be billed to the property owner at double the minimum monthly charge.

SECTION III: All resolutions or parts of resolutions which are inconsistent herewith are hereby repealed.



It is hereby declared as the intent of the Plum Borough Municipal Authority that this Resolution would not have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part hereof not been included herein.
